The Nomination forms of perspective candidates for officers received by the Nomination Chairperson will be presented and read to the Ohio Dance Masters Grand Body at the November Convention and must adhere to a vote by the membership to obtain that position to serve.

Nominations for officers will still be taken from the floor at the Ohio Dance Masters November Grand Body Meeting.

Anyone who wishes to run for office on the Ohio Dance Masters Board must be eligible by meeting the following criteria: He or she must be a member in good standing, who has been a member for two (2) years, and has registered and attended three of the last four consecutive Grand Body meetings. Candidates for the office of President must have served on the Executive Board for a minimum of one (1) year.

The member who is seeking nomination must be present at the Grand Body meeting at the November Convention for the elections unless excused by the Ohio Dance Masters President because of duty obligations.
